B. If this bill of lading contains or is evidence of a contract for the carriage of goods by water from any port in Canada to any other port, then this shipment shall have effect subject to the provisions of the Water Carriage of Goods Act, 1924, enacted by the Parliament of the Dominion of Canada, which shall be deemed to be incorporated herein, and nothing herein contained shall be deemed a surrender by the Carrier of any of its rights or immunities or an increase of any of its responsibilities or liabilities under said Act.

The provisions stated in whichever of said two Acts may apply shall (except as may be otherwise specifically provided in the regular bill of lading of the Maersk Line Far East Service referred to above) govern before the goods are loaded on and after they are discharged from the ship and throughout the entire time the goods are in the custody of the Carrier.

Nothing herein contained, whether by express statement, reference, implication or otherwise, shall be deemed a surrender of any rights or immunities or an increase of any responsibilities or liabilities which the ship, her owner, charterer, operator, agent or master or any carrier, bailee, warehouseman, or forwarder of the goods or the agent of any of them could have in the absence of this bill of lading.
